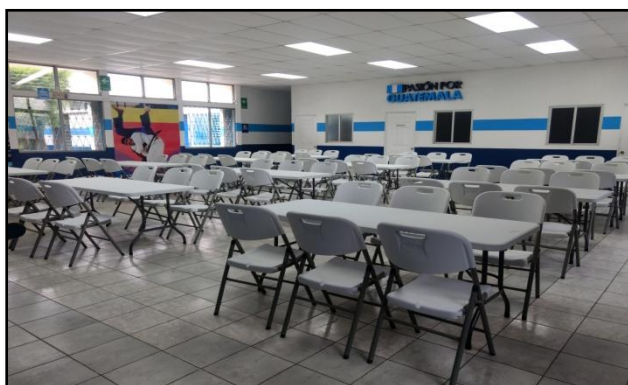

En cumplimiento a lo establecido en el Artículo 10 numeral 28 de la Ley de Acceso a la Información Pública y Decreto Número 19-2003 del Congreso de la República de Guatemala y la Ley de Idiomas Nacionales, el cual tiene como objeto regular lo relativo al reconocimiento, respeto, promoción, desarrollo y utilización de los idiomas de los pueblos Mayas, Garífuna y Xinca, y su observancia en irrestricto apego a la Constitución Política de la República y al respeto y ejercicio de los derechos humanos, la Confederación Deportiva Autónoma de Guatemala, procede a emitir el siguiente informe:

Con el propósito de elaborar el presente informe, se han definido como nuestros usuarios: **a)** Atletas que pertenecen a Federaciones y Asociaciones Deportivas Nacionales; **b)** Padres de familia de estos atletas y **c)** Personas que acuden a la práctica deportiva por salud; quienes de manera periódica utilizan las instalaciones deportivas a nivel nacional bajo la administración de la Confederación Deportiva Autónoma de Guatemala.

Para la recopilación de datos, nuestros usuarios de manera voluntaria, al momento de asistir a cualquier instalación deportiva, se anotan en una hoja de ingreso generada por la institución, en la cual consignan sus datos generales, incluyendo la pertenencia sociolingüística, dicha información se recopila diariamente y se consolida una vez al mes para generar y obtener los datos estadísticos, los cuales se analizan e interpretan a través de gráficos ilustrativos.

La institución actualmente cuenta con 58 instalaciones deportivas, distribuidas por regiones a nivel nacional, de la siguiente manera:

Región 1. Del análisis de los datos estadísticos recopilados mensualmente, se ha podido establecer, que, en cada Región, el español es el idioma habitual de los usuarios que asisten a las instalaciones deportivas de CDAG, sin embargo, como medida pronta de atención al usuario, se recopiló información de colaboradores que cuentan con conocimientos de los idiomas Achi, Garífuna, Kaqchikel, K'iche', Q'eqchi', en algunas instalaciones deportivas para apoyo si fuera necesario.

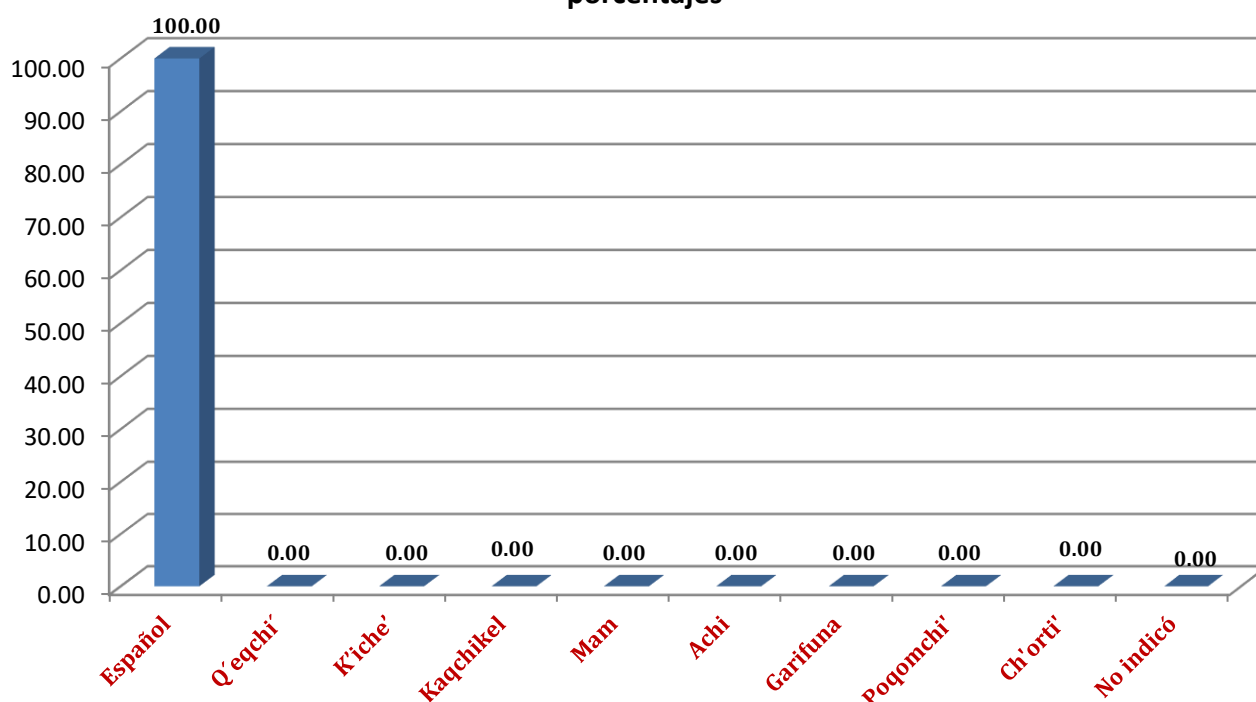
Las instalaciones deportivas se encuentran adecuadas al idioma que predomina en los usuarios que actualmente asisten a las mismas.

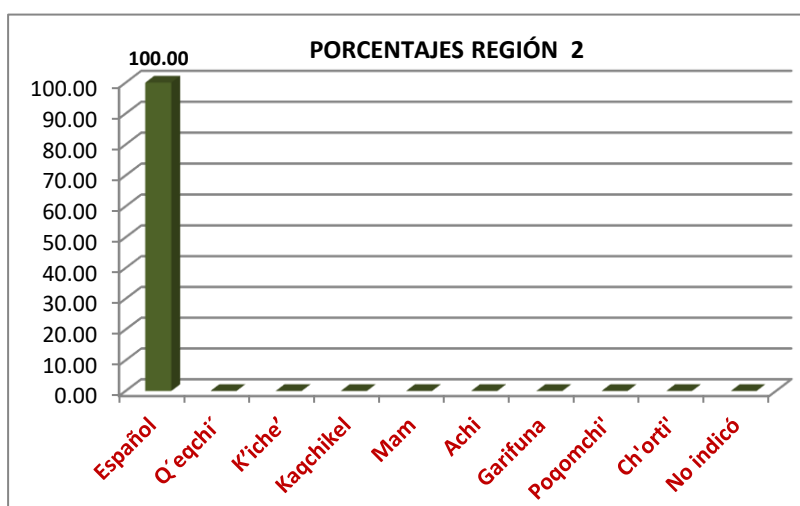

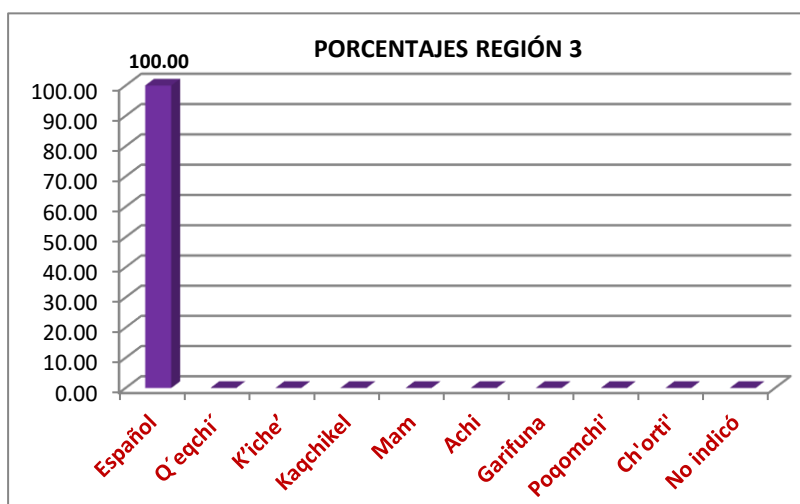

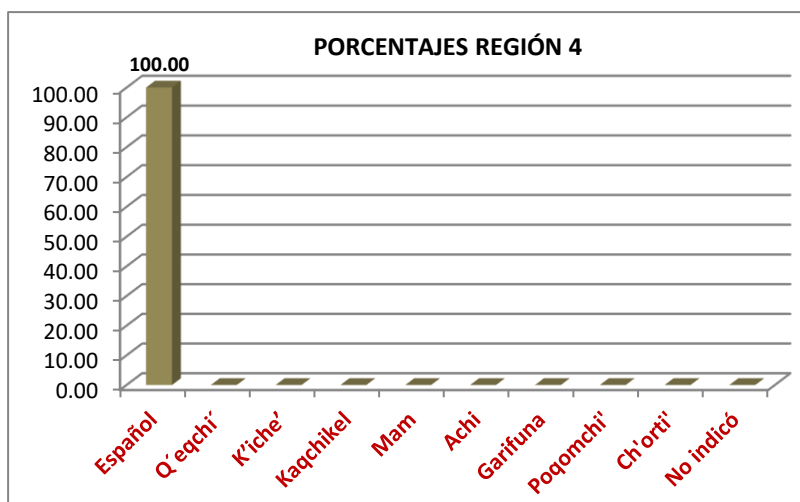

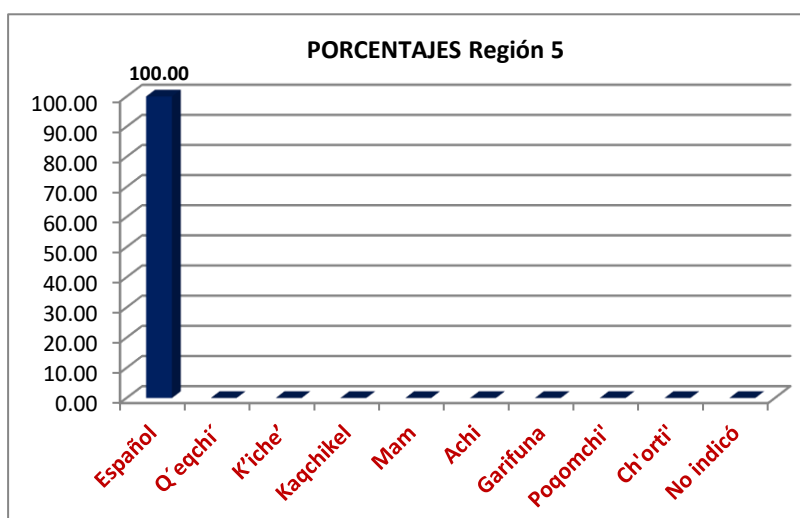

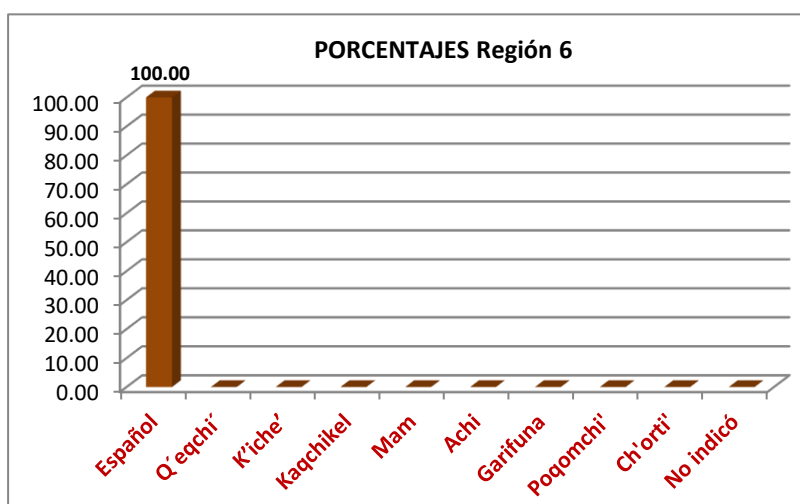

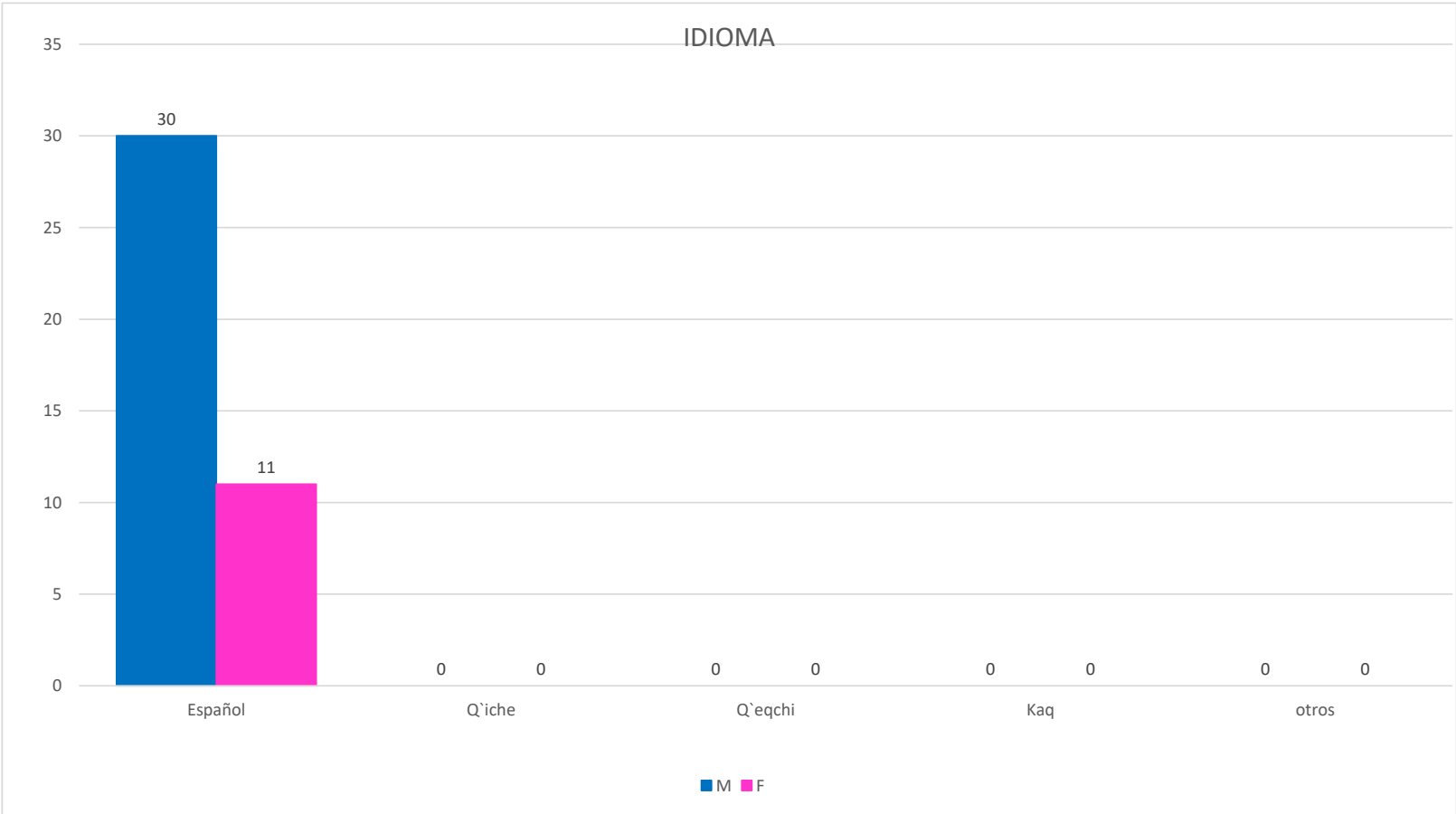
